# 2015-16 Annual Report Board Chair and CEO Report

In 2015-2016, the Board of our Centre adopted a new five-year strategic plan entitled 'Adapting to a New Environment'. Little did we know how prophetic this title and framework for our future would be. The first phase (2015-2016) of this plan was to be devoted to strengthening our organization's core while the deliberations and recommendations of the Ontario Special Needs Strategy were processed. Phase two of our plan, implementing the internal changes and additions necessary to carry out the regional recommendations, was slated for 2016-2017.

So, what happened? The Ministries involved with the Ontario Special Needs Strategy delayed decision on implementation until 2017-2018. In June of 2015, the Ministry of Children and Youth Services initiated the Autism Reinvestment endeavour, resulting in shifts from our School Support Program to our ABA Community Based Program, to be effective September 1, 2015. In August, 2015, the Ministry granted our Centre \$300,000 for the replacement of outdated electrical and mechanical systems at our 779 Base Line Road site, to be completed by March 31, 2016. In December of 2015, the Grey Bruce Public Health Unit approached our organization about taking over the Integrated Preschool Speech and Language Program there. In late March of 2016, the Ministry commenced a major restructuring of Autism Services across the Province.

It turns out that we had to simultaneously take care of our business – service to our clients – and strengthen our core, while also adapting to a rapidly changing environment. We found ourselves, at times, thinking of Tom Peter's quote from Thriving in Chaos: "If you are not confused, you are not paying attention."

In spite of these distractions and core strengthening activities, we expended a great deal of time and energy on our key, singular objective of "our clients at their best." This is evidenced by:

processing over 3,800 referrals

or 1.75 referrals for every hour we were open

- again serving nearly 8,000 clients; 47% of which accessed two or more services; 10% of which accessed more than five services
- applying more than 10,500 services in over 700 settings, not counting homes, across Southwestern Ontario
- providing over 264,579 hours of service via those distinct 10,500 services
- 70% of our clinical staff's time was spent on clientrelated activities.

In addition to the above, we also successfully achieved the following major enabling initiatives in 2015-2016:

- received an exemplary three-year accreditation award from the Council on the Accreditation of Rehabilitation Facilities (CARF)
- conducted a Workplace Assessment of our Centre's work environment
- participated in eleven regional planning tables of the Ontario Special Needs Strategy
- established a new classroom for children with Autism in Chatham, Ontario
- completed a due diligence assessment of the Preschool Speech and Language Program in Grey Bruce
- negotiated a new 5-year agreement with our fundraising partner, Children's Health Foundation.

Reflecting upon this time of extensive activity, we are a bit stunned at all that was accomplished. We are pleased, though, at the consistent focus of these activities on either 'our clients at their best', or on the potential for more services for our clients. This focus assists us in maintaining our usual positive and proactive approach, now very useful and necessary in the face of numerous, significant 'drivers' of change in the children's services sector.

## Meet Sam Denton ... In his Own Words

TVCC Ambassador, Parkside Boy's Soccer Team Member, Canadian Men's Para Soccer Team Member, University of Guelph Freshman Class of 2016 and Parkside Collegiate Institute Prom King!

I was born with Cerebral Palsy. CP is a result of an injury to the developing brain. It affects my ability to control my muscles when I do everyday things like

walking, writing, balancing, carrying a drink, or even speaking clearly. Everything I do takes more effort than the average kid; but I would never change a thing. My disability has given me so many amazing experiences in my life, and has never held me back from achieving a goal. I think it's because I don't think about my disability and I work hard every day.

#### Next to walking, my biggest

accomplishment as a young boy, was riding a bike. It took many years, but I finally did it when I was 8 years old. There was no stopping me after that. Much to my mother's horror, 2 weeks later my dad had me riding a dirt bike. Through the years, I have enjoyed many other activities such as baseball, golfing, skiing, four wheeling and snowmobiling. I love to do all of those things, but my passion really lies in the sport of soccer.

I started playing soccer when I was five, and I was hooked from the start. House league taught me that

soccer is a team sport and everyone has an important role to play, on and off the field. I found myself drawn to the goalkeeper position from the beginning, and was regularly seen waving my hands at the coach and yelling to please put me in goal. Unfortunately, my house league folded when I was 12 and my teammates went on to play competitive soccer. I missed soccer terribly for the next couple of years and thought I was doomed

to become a video game playing couch potato. Then something amazing happened to me. It was a huge fluke, but I encountered my TVCC physiotherapist Liz, whose husband just happened

to be the assistant coach of the Canadian Men's Para Soccer Team. Paralympic Soccer is a 7-a-side soccer game for people who have traumatic brain injuries, have survived a stroke, or have cerebral palsy. She encouraged me to give it a try. The first time I met the coach to show him my soccer skills, I could barely endure the drills he put me through. After attending a few training sessions with the team, it became a dream of mine to be on Team Canada. I knew it would take a lot of hard work and commitment. One year later, I achieved my ultimate goal and was rewarded with a spot on the roster for the CP World Cup in England last June. One of the proudest moments of my life was walking on the field with my teammates, wearing the Team Canada Jersey, and representing my country. I am

now physically in the best shape of my life, and I am a carded member of the Canadian Men's Para Soccer Team. My current goal is to gain a spot on the team for the Denmark World Cup in July.

People who have disabilities are challenged daily by simple everyday tasks. The amazing thing about people with disabilities is they have the ability to overcome and reach heights many people never thought possible. Whatever your goals may be, big or small, work hard and never give up. I will always be thankful to TVCC for the help they have given me over the years, and for the opportunity to share my story as I hope to inspire others to follow their dreams.

## Notes to Summary Financial Statements

The summary financial statements are derived from and are in agreement with the audited financial statements. The summary statements consist of major subtotals and totals from the audited financial statements and exclude certain presentation detail and disclosures required by Canadian accounting standards for not-for-profit organizations.

Administrative costs are allocated to the programs based on program costs as a percentage of overall operating costs of the Centre, staffing and occupied space. Donations and grants received for specific capital purchases are recorded as deferred contributions, and brought into revenue to offset the related amortization.

These investments are subject to market value fluctuations and the Centre records these investments at fair market value. Accordingly, the year-end market values and investment income for the year include unrealized loss of \$318,427 (2015 - gain of \$277,478).


